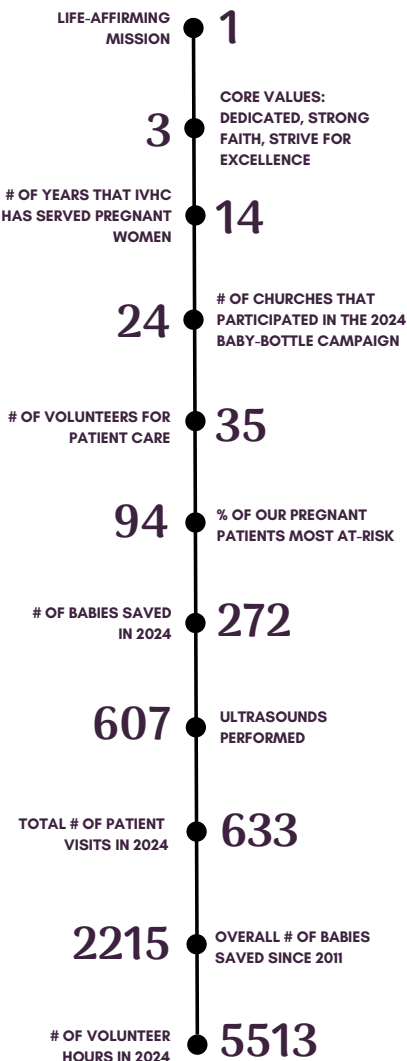


AND SAVING BABIES

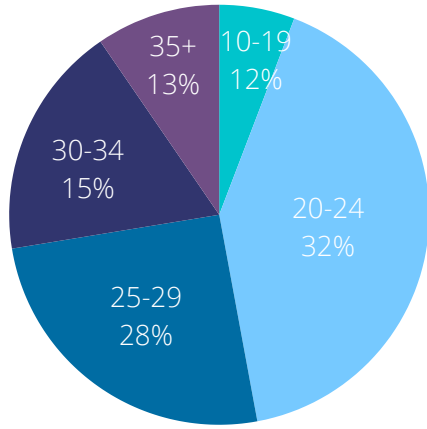

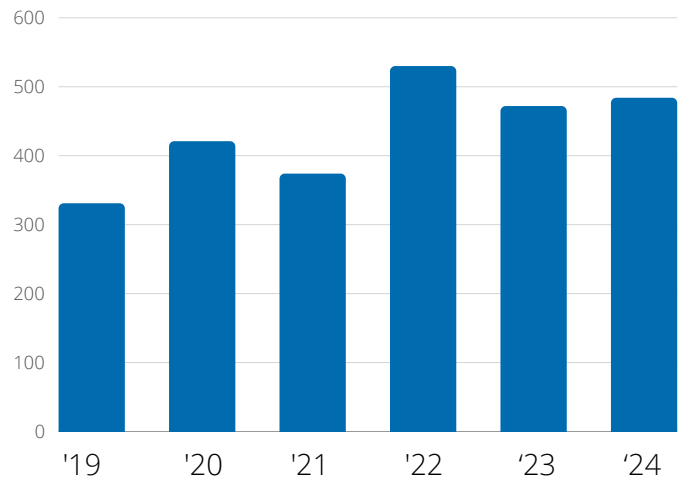

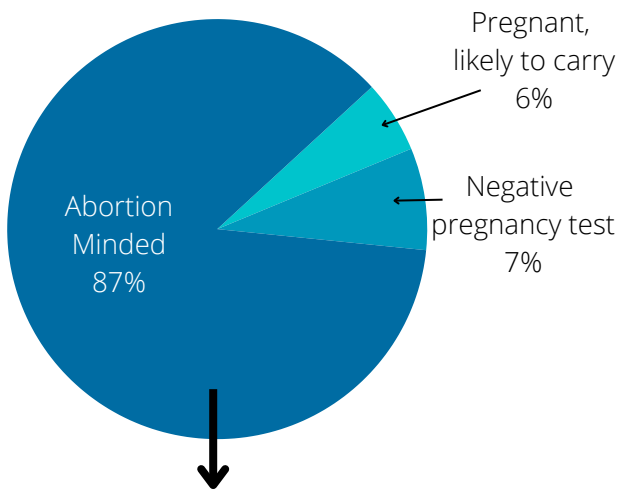
PATIENT DEMOGRAPHIC-
AGE (YEARS)



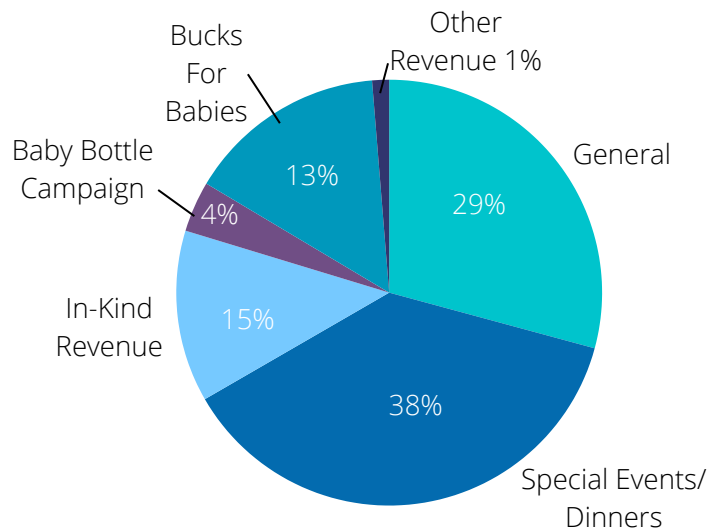
PREGNANCY PATIENTS PER YEAR



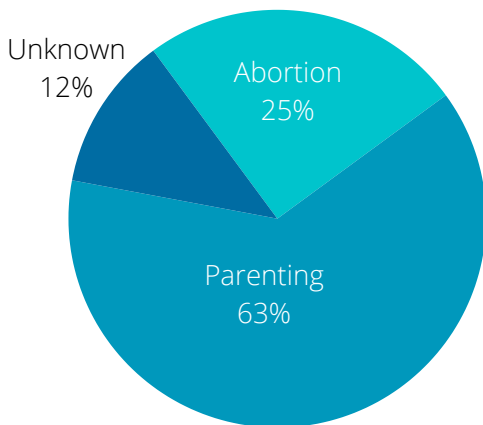
PREGNANCY PATIENTS
IN 2024



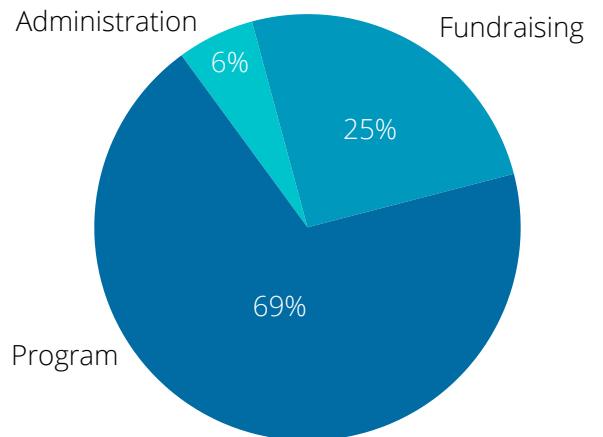
2024 INCOME
